1.0 BACKGROUND

The Ministry with funds from EU through COMESA intends to construct a ware house in Busia Border Export Zone, Busia Local Government. In this regard, the Ministry advertised tenders for contractors and subsequently held an information meeting on the 21st June 2019 which preceded the site visits.

1.3 COMMUNICATION FROM THE MINISTRY OF TRADE INDUSTRY AND COOPERATIVES

The Ministry welcomed participants for the site visit thanking the prospective bidders for being able to travel to the project site.

He noted that the Ministry is ready for construction with the master plans, Bills of Quantities and all the documentation

He further noted that for Busia specifically the designs are for the warehouse.

It was noted that on 21st June 2019, the Ministry organized a clarification meeting where intending bidders met and asked questions to enable them bid well.

The Ministry informed the participants that the meeting is purposely to familiarize the bidders with the site and this visit is compulsory.

It was noted that, whereas the previous clarification meeting was not a must, the site visit is compulsory and that any company that has not attended will not be eligible to bid.

1.4 COMMENTS FROM THE PROSPECTIVE BIDDERS

1. The documentation shows a different road different from the actual road alongside which the warehouses are to be built and therefore they need to change on their layout.
2. The place has no water and the nearby streams have little water.
3. The site is clear and accessible for the construction works
